<u>Call to order</u>: The meeting was called to order at 9:10 am by President Dale Meadowcroft

Moment of Silence: A moment of silence was observed.

Administrative Report: Brian Grundusky:

- Covid BV has been experiencing sporadic cases with minor symptoms. Those affected are quarantining. A post-holiday spike is anticipated in the next few weeks.
- Financial BV met its operating revenue for November and is expected to meet this marker for the year 2023. Figures should be available in the next few weeks. We exceeded budgeted expenses by about \$100,000 for November due to contract labor and Facilities expenses.
- Occupancy remains strong. Currently, there are approximately 5 open units in Residential Living, many of which are 1 bedroom Court. Assisted Living has 2 openings and Skilled, which had been full, lost several residents due to their passing and expects to fill those openings shortly.
- Inspections Assisted Living (MapleWood) annual inspection completed. 10 minor deficiencies were identified and have been corrected. Brian gave an example of a "minor deficiency," where, of 75 trash cans in MapleWood, 2 were found to be without lids. The

inspections team, upon departing, noted that Bethany was a "wonderful place" and said that a recent inspection of another facility found 48 deficiencies. Still waiting for the state Department of Health, who surveys for both state and federal governments, to do their annual 2-part check (clinical and physical setting) in The Oaks. A mock survey to prepare for this inspection went well in the fall and the inspection is expected to take place in the next few weeks.

- Springfield's/Brain Health initiative Plans are being finalized and estimates (usually on the conservative side) are 5 7 months for completion. The sequence is to obtain final numbers, apply for permits and then begin construction. Plans will be in place to minimize disruption to residents during construction.
- Peoples Bank Peoples has been bought by Orrstown Bank, whose philosophy about having banks in long term care facilities is not known at this time. Should Orrstown choose not to continue at BV, Brian has a good lead on a future bank.

<u>Minutes from December 5, 2023</u>. Motion to accept was made by Dennis Plymette, seconded by Bill Middendorf, and approved unanimously.

<u>Correspondence</u>: Several of the notes of thanks received from Associates receiving money from the RC sponsored Associates' Appreciation Fund were read.

<u>Financial Report</u>: Dale Meadowcroft, Treasurer, submitted the Statement of Activity and Statement of Financial Position as of December 31. Dale noted that more than \$1000 was made on investments but stated that the real story was the amount of money made under Kathy Salmon's leadership of the BV Fairs and the clubs, whose members put forth great effort throughout the year to bring money into the accounts and, therefore, result in what the Council can do for the residents. New Business:

• Well Being Communications: Justin Margut
Justin spoke as the new Director of Well Being, which will now consist of Wellness,
Resident Life, and activities of MapleWood and The Oaks. Asbury and its communities
are now re-aligned. He noted that a strength here at BV is the resident-formed and run
clubs and asked for better communication between club spokespersons and his office. An
example cited was the changing of dates or details of club events without notifying his
office, and the confusion that results from not having current information posted on Icon.
He would like to meet with the heads of groups on this topic to firm up communication.
He and Kristen Juchem are working on ideas and division of labor to enable this and
plan for other changes to come. Dale Meadowcroft, as President of the RC, stated that he
would be the contact person for committees, clubs, etc. on the Council.

Kristen Juchem, the new Lifestyle Enhancement Manager, spoke enthusiastically about her goal of better serving residents. One of her duties is placing orders for clubs, groups, etc. Kristen stated, for example, that if a group needs batteries, they should contact her. Suggestions or comments can be directed to Kristen or Justin.

• Introduction of representatives to join the Executive Committee: Dale Meadowcroft By-laws direct that, with a current non-voting Secretary and Treasurer, 2 Council members be appointed to the Executive Committee. Harry Boswell (E. Apartments) and Carol Pennington (E. Cottages) have agreed to serve and will provide a balanced representation to the committee.

Motion to accept the above names was made by Dale Meadowcroft, seconded by Claire Powers, and carried.

Vision for the Residents' Council: Dale Meadowcroft

"Peace, hope, love, joy and encouragement," began Dale, who wants to make Bethany Village a place people want to move to. All were asked to participate in carrying out this vision by reaching out to those in one's neighborhood and thinking of other ways to be of use. Dale cited the grand vision being carried out by Ray Saunders, who has regular, well-attended meetings in the West Apartments, and that of a resident who filled and carried water in The Oaks hydration program until the person was no longer able, as examples.

While it is the responsibility of committee heads to recruit for their committees, members were asked to notify the chairs if they were interested in a particular group's mission, as members are always needed.

<u>Other:</u> Tom Johnston, representing the Ecology Team, which meets monthly on the 3rd Tuesday at 11 am, spoke of two recent offerings by the team. <u>The Letter</u>, a movie and discussion about climate change was well-attended, as was a discussion about recycling by our provider, Republic. The group's new chair is Margaret Pepe, and their goal is community service.
