Call to order: The meeting was called to order at 9:29 am by President Dale Meadowcroft

<u>Moment of Silence</u>: A moment of silence was observed to ask those present to keep our leadership in our thoughts.

#### **Administrative Report**: Brian Grundusky:

Highlights of Brian's report:

- Covid As anticipated at this time of year, there has been an increase in cases, with a significant number recently in The Oaks, all minor in nature. There are cases of flu (a little more than usual), norovirus and bird flu popping up. If you see a dead bird, notify BV and do not pick it up.
- Financial The final audited report for 2024 is not in, but preliminary results look good. We hit targeted OR by about .01%. We had some issues in the second half of the year with some occupancy issues, specifically in skilled nursing, and health insurance costs. Between December 31 and this date, 15 residents passed away in The Oaks, a high number. From a financial standpoint, occupancy is now up to 67 (of 69 beds). Specific

numbers can be found in the Campus Outreach Report, 7, below). We did have 15 contract signings, a positive for income.

- Building issues, West Cold temperatures recently impacted a sprinkler system outside the hallway of the therapy room, and there was also a significant issue in The Oaks entrance, resulting in having to shut down entry to the door. We are looking at options for these areas. A "dry" sprinkler system and the use of glycol, an antifreeze type product, are being considered. In addition to these issues, BV must follow town guidelines, which state that when the temperature drops to a certain point, we must switch from natural gas to fuel oil. When this was done, a brief delay with the boiler in the switching process resulted in some gaskets leaking, which caused leaks in 15 areas. This will be an insurance claim filed (BV does not self-insure for this), after a deductible of \$100,000 has been met. Brian noted that there were no issues on the east side of campus, which was built in 1992, while the west was built in 2002 by a different builder. Bethany will not use the builder used for the west in the future.
- Benevolent Care, clarification for a recent e-mail sent by Todd Andrews Each Asbury community has a benevolent care program. The purpose of the e-mail was to show residents nearing the point that they might need to apply for benevolent care a "Tool Kit" that was available to them. Brian stressed that nothing has changed with the process. In addition, dollars raised for benevolent care in Bethany Village are only used for Bethany residents.
- Electronic lock update Cottage residents should be getting their badges this week. The project is now about 90% complete. The vendor will not be used again. A time frame for when residents can obtain extra badges will be upcoming.
- Bank update PSECU will be installing an ATM in the next few weeks. It will be in the same place as the former ATM (near the Bistro) and will be able to handle withdrawals and deposits.
- Building assessment 2025 has been designated as the time frame for each Asbury community to receive a total infrastructure (pipes, walls, etc.) assessment of all buildings. This is done approximately every 10 years.
- Phase 3 A possible start date for this 2-year project has been set for June 2025. There is still pre-work to be done, including raising further money. With contributions from Asbury and what has been raised at BV, it appears we have enough to start. Brian plans to pair an associate with a resident representing a given area (example given, Kerry Butz for the Furniture Room, Kathy Salmon representing the BV Fair, Ellie Meadowcroft for the Library) to closely look at individual areas and plan for things such as storage, etc.

Questions and Comments – It was noted that BV is the only area among surrounding townships that is not able to recycle glass. Brian stated that we will soon be changing our vendor for trash pickup, and that issue will be discussed with the new company.

These beautifully crafted boxes will be placed prominently in the Springfield's dining room and John and Annie's Bistro. They are valuable for constructive feedback to the dining services team. Highlights of the Facilities Committee meeting January 28, 2025, with Mark Ruiz.

- AV Project A replacement part is missing.
- Center Apartment projects still waiting on delivery of the carpet.
- Court Canopy sprinkler system will resume after the ground thaws.
- Solar Charging Station project is completed. Working on completing visual instructions.
- Sink hole work will resume when the vendor is available.
- Door Access for cottage residents Badges expected soon. Cottage residents will be notified when they can pick them up.
- West Apartments filters changed; motion-activated switches in the multi-purpose room are installed.
- West Apt. elevator frames and touch-up painting February.
- Rife Center mikes set outside on the table.
- Dryer Vent Cleaning will start in February, cottages first.
- Infrastructure Study See Brian's report for detail. Last one was done in 2008.
- West Apartment building problems see Brian's report.

#### Questions and comments –

- East Apartments- door 36, the main Court door is not always locked, leading to security concerns. It is locked now as work is underway.
- In the Rife Center, performers behind the speakers can't hear anything that is going on.

- West Cottages, smoke detectors Is there a schedule for changing batteries? Fire extinguishers should be recharged or replaced on a regular basis.
- West Apartments: When will the garage door be repaired? Answer when all parts arrive. Door 47B was open for several nights. This appears to have happened because an adjoining door did not have a good seal. Solar charging station for EVs is free for residents, one car per day. Heating problems the boxing room is too hot. Water leaks on the 4<sup>th</sup> floor that were caused by an HVAC coil have been fixed. There is excessive heat in the West Commons Room.

- Phase 3, Capital Fund: We have around \$625,000 raised and need \$2.8M. The foundation has agreed that they will count as raised, money that has been pledged. Pledges and money given are included in the \$625,000, leaving about \$2.1M to be raised. Dale encouraged residents to consider the impact of these improvements on the Residents' Council and our community.
- Addendum announcement: Dale reviewed the revised addendum to the By-laws. Per information sent to members prior to the meeting, Dale reviewed the formal addition of the Volunteer Committee and History Committee and the removal of the Special Events Activity, due to lack of need for same. These actions may be made by the Executive Committee and were brought forward to inform the Council.

**Items from around the table,** an opportunity for members to share their thoughts and constructive feedback.

The Wellness socials being presented to small areas by that group were favorably talked about by representatives from the  $2^{nd}$  and  $3^{rd}$  floors of West Apartments. Both floors reported the socials, which met by floor, were well attended and well received.

Dale has been talking with Bill Middendorf about what the West is doing, with regards to improving communications with residents in the East Apartments. Ray Saunders briefly reviewed what was started several years ago in response to complaints that West residents didn't have access to their representatives and didn't understand what was going on in the Council. The group formed to address this is called News and Views and meets monthly. Council members share what is going on and they answer questions. 60 - 70 residents show up for News and Views and it has improved communications. Tony Wright, a newly elected Council member from the West Cottages, was commended for his e-mail blasts, another way of keeping residents

informed and connected. Dale also mentioned that perhaps we should think of living interdependently, rather than independently and care for our neighbors.

There was a question about notification and the formation of teams for the Family Feud. Following the meeting, Dale reached out to Bethany Malykh, Wellness and received the response below. Feel free to contact Bethany with your thoughts.

I don't know if we utilized paper flyers as much this year with Family Feud. We posted them in a couple common areas on West and East. However, it was also sent out as an email to all residents asking for teams to sign up as well as in the weekly email newsletter that I put together and sent out. The announcement for people to come out and watch has been on ICON and also in the weekly email newsletter that I send out. Justin can speak to me if it's been on morning announcements as well? We can try to make sure things are announced there too. If those residents could let us know the ways that they most utilize to find information, that would be helpful for us to know what avenues we should be focusing our efforts on communication wise.
