Guest Presentation Bob Saline

BV Resident, Bob Saline, spoke for the Ecology Team on the topic of solar energy. There has been increasing interest in solar with the rising cost of electricity, and much has changed over the last 10 years...panels have been improved, they are lighter and more efficient, require slightly less space and can last 40 years. Even at the 40-year mark, Bob stated that the panels will have lost but a small amount of their capacity to generate electricity. In addition, electricity generated but not used can be sold on the grid.

Ann Marie Judson reported that she and Sandy Jones had spoken via zoom recently to J. D. Shuman and Susan Mayernick of Asbury regarding Phase 3. A possible starting point for solar installation at BV is on the roof of the new construction.

The Ecology Team has reached out to the firm of Greenworks Development, headed by Doug Neidich. Greenworks has done installations at Masonic Village, Londonderry Village, Cumberland Valley School district and two locations of UPMC, among others and provided a power point presentation and other information to the team. Cost has not been discussed, nor have bids been sought.

The Ecology Team requested the Council and individual residents to put the concept of solar at BV to Brian Grundusky while he is still here and others in senior management through e-mail and talks. Noting the rising cost of electricity, the cleanliness of solar and that BV, as a non-profit, there was affirmation for solar at BV from those in attendance.

9. Dining (C) – Judith Sommer and Ann Swenson, Co-Chairs:

Co-Chair Ann Swenson stated that the committee has had its first meeting, and that the Dining Chefs are outstanding.

<u>10. Executive Committee</u> (SC) - Dale Meadowcroft, President, and Chair: See New Business, potential Executive Officer slate.

11. Facilities (C) – Carol Pennington, Chair:

Highlights from the BV Facilities Meeting, October 30, 2025

New Hires: Steve reported that new laundry staff (agency and Bethany Village) and two new maintenance technicians are starting soon. There is still a need for a driver's position and a dedicated housekeeper (for East).

West Apartments

- Hot water: Thee's an issue with hot and cold water mixing in West Apartments due to mixing valves and plumbing setup. The team is investigating and making small fixes, which have shown improvements in some areas. They will check if specific apartments are on their list for this fix.
- An employee was seen using a phone while operating a large machine in the hallways. This is a safety concern.
- Trash Rooms: There is no signage for trash rooms on the West side, making it difficult for new residents to locate them. The trash room near # 1119 is very dirty. Steve stated that Waste Management processes, including compactors and recycling collection, are being reviewed due to safety concerns and inefficiency.
- Cleaning Carts: Cleaning carts are being left unattended for extended periods, raising concerns about cleaning staff's work habits. Steve will inform Jessica, housekeeping manager about this.
- Apartment Air Ducts: A resident in apartment #1126 is experiencing a gritty film on surfaces, despite a recent filter change, suggesting a potential with HVAC or duct work.
- Stairways: Need cleaning.
- West Garage: Significant accumulation of waste and leaves, particularly in certain areas. Concerns about residents storing excessive items in the garage.

East Issues:

- Shuttle service: A program last week had shuttle service until only 7 PM, causing issues for attendees needing to get home. One shuttle was damaged at an offsite event but has been repaired and is now back in service.
- Rife Center Parking Lot Lighting: The Rife Center parking lot is dark at night when people are leaving after programs, posing a safety and liability issue. Steve reported that the installation of new outdoor lighting is in the capital budget, and a follow-up will be done with Brian regarding timing.

- Softener: Water on the East side is not as soft as it should be due to a sinkhole affecting the brine tank for the water softener system. This is a mechanical concern.
- Bistro PA System: Outdoor speakers of the Bistro's PA system cannot be turned off, an ongoing problem. The system is old and cannot be easily reprogrammed.

12. Garden Club (CL) - Cindy Lindsay, Chair:

Some gardeners are still harvesting fall crops, but the garden will soon be put to bed for winter. At the fall Garden Club meeting on October 17th, attendees discussed ideas to consider for the 2026 season. Art Lindsay met with Steve Walck to review Garden Club issues related to the Maintenance Department. Anyone interested in joining the Garden Club and obtaining a plot, please contact Cindy Lindsay. Spring will be here before you know it!

13. History (C) - Joan Bretz, Chair:

Work continues on the 2025 Archival Yearbook.

Dale Meadowcroft stated that two new Windows 11 computers have been installed in the computer lab.

15. Landscape Committee (C) - Maggie and Ray Pepe, Co-Chairs

The Landscape Committee held its first meeting on October 15, with 9 members and Steve Walck present. Primary focus of the meeting was member introductions, followed by a discussion of landscape interests and priorities. The November meeting will be held November 19. The focus will be on the efforts of the previous Beautification Committee led by Alex McKechnie and George Tjiattas.

19. PARCR (C) - Lowell Starling, Chair:

October 8, 2025, PARCR Quarterly Meeting: The October meeting was held on the scenic and massive Masonic Village campus in Elizabethtown.

This meeting was the initial use of new AV technology to address the challenges of running large hybrid meetings at different member communities. PARCR has invested in a new set of Audio/Visual equipment, which PARCR can run independently or in synchronization with the

AV equipment at the host community. All indications are that it worked well and will help with the plans for growth.

Coming Next:

January 14, 2026, PARCR Quarterly Meeting: held at Bethany Village. The keynote speaker will be Lori Dierolf, President, Open Door Training, who is an expert on cognitive issues. Her topic will be "Is it Dementia or Old Age?" As a teaser, if you cannot find your car keys, that is aging, but if you find your car keys but do not know what to do with the, that's dementia. We will also hear from LeadingAgePA and NaCCRA about their new initiatives.

Farther Out:

April 8, 2026: Site to be determined. Presentation topics being considered include a return by the PA Insurance Department to provide an update on their work regulating CCRCs.

July 8, 2026: The meeting will be held at Garden Spot Village, New Holland Pa., with speaker Susan Saxinger, Executive Director of Pa. Assisted Living Association, who has been appointed to Pa. Long Term Care Counsel, in addition to our usual lineup.

Other updates:

The Board agreed to form a task force to update the CCRC statute, which has not been revised since 1985. The focus of the statute includes financial transparency, deposit handling, and arbitration provisions. The task force will include corporate members and would also engage an attorney for legal review before submitting proposed changes to the legislative reference bureau. The Board agreed to start the process of forming a Task Force.

- Proposed Residents' Council donations 3 proposals were put forth by the Executive Committee after soliciting ideas in last month's Minutes to appropriate monies on hand.
 - 1. After speaking with Jacob Kanagy and learning that both Nursing and Associate's Scholarship funds were well-funded, Dale proposed that the Council give \$10,000 to the Associates' Appreciation Fund.
 - 2. The Woodshop requested \$1300 for an air filter and an enhanced planer. The shop is able to buy raw wood (not planned) in bulk and then plane it to achieve substantial savings over purchasing already smoothed wood.
 - 3. The old cooler in the Collegiate Café has poor temperature control and other limitations. A superior and more functional cooler, able to be opened from both front and back have been recommended by the Cafe at a cost of approximately \$5,600.

The above recommendations, which total approximately \$17,000, were accepted by the Council.



Price per megawatt hour of electricity, by source*





 Solar energy production has the least harmful affects on our environment. (Is this true and are there sources proving that?) Solar, wind, and nuclear all have very low effects on the environment. Here's one of many charts available on-line:



- Our current governmental denial of solar energy production is putting enormous risks on our environment. (Is this true and are there sources proving that?) That's true because of the chart above.
- Other countries are investing in solar energy production and the US is falling drastically behind. (Is this true and are there sources proving that?) China is outpacing US solar implementation by far. Here's a good graph on that:



- There are means to prepare for making solar energy production at Bethany Village even when our
 current government is sidelining solar. (Is this true and are there sources proving that?) True, but
 only because GWD/SRE has purchased a large inventory of solar panels that we can allocate to
 new solar projects to meet the government's 5%-of-total-project-cost safe harboring requirement
 to secure the federal solar tax credits.
- A recent analysis of placement of solar panels at BV while not impacting the landscape indicates several viable options. (Is this true and are there sources proving that?) We haven't explored that with you yet. When I get your electricity bills from Susan we'll do an analysis of how much we could save BV by doing a 100%-electricity-offset solar project, then we'll work with you to try to find enough roof and ground space to get to 100%.
- With the current governmental sidelining of solar production and the increased reliance on fossil fuels, current energy rates will increase for every resident of BV either in cottages, apartments or care. (Is this true and are there sources proving that?) There are plenty of news articles on-line regarding dramatic electricity price increases in Pennsylvania. Here's one of them:

- Other institutions like BV have recently started using solar panels to generate electricity such as??? Masonic Village and Londonderry Village are the two retirement communities in the area that GWD/SRE has done solar projects with. Descriptions of those projects are in the attached slide deck, along with descriptions of a number of other projects. Overall, GWD/SRE has done almost \$600 million in solar installation since 2010.
